Contest Official Rules

Eligibility: No purchase or obligation necessary to participate and win. Registering contest participants must be members of Guardians Credit Union. All registering participants must be 18 years of age or older at time of contest participation. Employees of Guardians Credit Union, their immediate families (spouses, parents, children and siblings, and each of their respective spouses), and members of the household of such individuals are not eligible to register for the contest

How To Enter the Contest: The Contest begins at 12:00 am Eastern Time ("ET") on August 10, 2017 and ends at 11:59 pm on August 31, 2017 ("Contest Period"). Visit Guardians Credit Union's Facebook page and follow the instructions to complete the online entry form.

To participate, upload an original photo with a brief caption of your vacation. All material submitted to Sponsor in connection with this Contest shall be referred to herein as the "Entry" and the person submitting the Entry shall be referred to herein as the "Entrant". Entrants may enter one time during the Contest Period. Entries deemed inappropriate or unsuitable, in Sponsor's sole discretion will be disqualified. Each Entrant attests that he/she has made all those depicted in the Entry aware that he/she is submitting an Entry containing them in this Contest, and that all depicted have agreed that Entrant may submit such Entry. Further, if any minor is depicted in an Entry, Entrant must obtain a Release from that minor's parent/legal guardian. By entering, each Entrant understands that any Entry, in its entirety or any portion thereof, will be posted on the Sponsor's Facebook page and/or used in other Sponsor-selected media, and hereby grants all rights necessary to the Contest Entities, or any of them, to so post, broadcast and/or use such Entry or portion thereof. In Sponsor's discretion, Entrants may be required to obtain and submit signed release forms at any time from each of the people appearing/depicted in an Entry. Failure to do so within time frame specified by Sponsor may result in disqualification. Normal Internet access and usage charges imposed by Entrants' online service will apply and are Entrant's sole responsibility. Entries become the property of Sponsor and will not be returned. Sponsor is not responsible for lost, late, misdirected, corrupted, incomplete or damaged Entries. Proof of submission is not proof of receipt by Sponsor.

Contest Entry Requirements: In the event the Sponsor, in its sole discretion, determines that any Entry contains content that does not comply with these Official Rules or does not otherwise comply with regulatory guidelines, Sponsor reserves the right to disqualify the Entry or, if Sponsor determines, edit the content of the Entry. All Entries must be the sole, original work of the Entrant. Entrants may not copy or otherwise

plagiarize any portion of the Entry from any other source. Entries may not have been published previously or have been submitted in any other competition. The Entrant must own all rights in and to the Entry. Entries must be in keeping with Sponsor's image, or desired image, or they will be disqualified. The Entry may not contain obscene, profane, lewd, defamatory or inappropriate images; and may not include nudity, acts of violence, acts that appear to cause injury or harm, or acts that are illegal or dangerous, as determined in Sponsor's sole discretion. Entries may not contain any third party materials, and may not contain any materials that violate or infringe (or may be at risk of infringing) any third party rights, including without limitation copyright, trademark rights, privacy rights (including portrayal in a false light), publicity rights, or other intellectual property rights. Entries should not contain logos (other than Guardians Credit Union), marks that identify a brand, names, license plate numbers or other personal or proprietary materials of any entity or person living or deceased. Sponsor has the sole discretion to determine whether an Entry is eligible. Any Entry that violates this section or is otherwise objectionable (as determined solely by Sponsor) will not be considered and will be disqualified. Automated, script, macro or robotic Entries will be disqualified.

Transfer of Rights: By submitting an Entry, Entrant hereby grants irrevocably assigns to Sponsor the Contest Entities the exclusive irrevocable, perpetual, worldwide all right, title and interest in and to the Entry, whereby Contest Entities may including all rights to reproduce, publish, edit, market, store, adapt, assign, sell, dispose of, distribute, have distributed, publicly and privately display, communicate, publicly and privately perform, transmit, have transmitted, create derivative works based upon, and promote the Entry or excerpts of the Entry (as such may be edited and modified by the Sponsor in its discretion) in perpetuity, for editorial, commercial, promotional and all other purposes (including posting on Sponsor-affiliated websites, the Website, and/or other Sponsor-selected media). Entrant hereby disclaims any rights, including any copyright or any other intellectual property right, in or to the Entry following the assignment contemplated hereby.

Voting to Determine the Grand Prize Winner: Entries will be judged by visitors to the Sponsor's Facebook page. Votes in favor of an entry will be through "likes" of the picture. Each visitor may vote for one entry, and may not vote more often than once per 24 hour period. Sponsor reserves the right to utilize 3rd party software and apps to limit the number of votes by a visitor to the page. Votes by a visitor in excess of a daily per visitor maximum will not be counted.
